Claife Parish Council Minutes of Parish Council Meeting held at High Wray Village Hall Tuesday 5th March 2024

014/2024 **Apologies**

Apologies were received and accepted from Parish Councillor A Brodie & Unitary Councillor S Pender.

017/2024 Minutes

Resolved The Council approved the minutes of the last meeting held on 23rd January 2024.

018/2024 Public Participation

- a) Reports were received as follows:
 - i) Police

The Clerk reported that there were no reports to the Police in the Parish in January 2024.

020/2024 Updates on Ongoing Issues and Actions

a) Windermere Ferry

The Clerk reported that Councillor Brodie has advised that the planned Windermere Ferry meeting did not take place.

b) Road gritting/snow ploughing arrangements

Councillors attended Highways meeting on 29th January 2024. Councillor Stanton asked Highways for road closed signs to be installed where roads are blocked by snow and Councillor Hilton asked for road closure signs to indicate the location of the closures. An email has since been received from Highways outlining their training requirements for contractors & contract conditions for farmers employed by Highways to snowplough. Highways are undertaking a review of gritting arrangements and confirmed they are prepared to provide salt to Parish Councils but not to contractors as this has been difficult to manage in the past. Additional Grit Bins can be requested from Highways. Highways will be undertaking a review in the summer of winter arrangements for 2024/5. The Clerk advised that the specified LANTRA courses (according to the LANTRA website) are available through Cumbria County Council, which presumably is now the Unitary Council. **Resolved** To request details and costings of LANTRA training.

c) Council Land

Councillor Hilton reported the Alistair Irving is undertaking the work on the path near Esthwaite. The Clerk reported that Councillor Brodie has advised that Richard Tanner of the National Trust has agreed to walk the Esthwaite public access land with her to identify trees that have been affected by Ash dieback disease once the leaves appear.

d) Environmental & Water Quality

Councillor Denyer advised that a response has been received from United Utilities, on questions submitted following attendance at the event regarding water management at Near Sawrey, but they are not in sufficient detail or satisfactory. United Utilities (UU) state that they plan to advise residents and local organisations once they have decided how to proceed, but do not intend to consult on proposals. She also advised that the National Trust similarly would prefer that UU

engage at an early stage in the process as it will affect how the National Trust manage their properties and land. Councillor Denyer also advised that UU are exploring a project similar to the Lake Annecy Project with the aim to stop sewage discharges into Lake Windermere by installing sewage pipelines along the side of Lake Windermere then south through the Cartmel Peninsula to a proposed treatment plant at Grange-over-Sands before discharging into Morecambe Bay. Windermere & Lakes Town Councils have both adopted statements supporting the project (referring to an email issued by United Utilities which Claife Councillors have not received) and Windermere Town Council has also set up an advisory group. Councillor Stanton suggested that disconnecting surface water from the sewage system would solve most of the problems. Councillor Hilton is concerned that the cost of the project is three times the annual income of United Utilities. Councillor Denyer proposed that Claife issued a statement supporting sewage system improvements including the Lake Annecy Solution. The Clerk advised that Peter Cook of Windermere Town Council has offered to attend Parish Council meetings to explain more about the Lake Annecy solution.

Resolved To invite United Utilities to a future meeting to explain the proposals for Near Sawrey and Lake Windermere in more detail and also invite representatives from the National Trust to attend

Resolved To obtain a copy of the United Utilities email referred to in Windermere Town Council's statement.

Resolved To invite Peter Cook to a future meeting to explain Lake Annecy solution in more detail. **Resolved** To defer consideration of Claife Parish Council making a statement on sewage system improvements until more information is received from United Utilities.

The Clerk reported Councillor Brodie has advised that she has attended the first Wilfin Beck water quality training day including sampling and analysis. Six points were sampled and analysed by 2 volunteers, South Cumbria Rivers Trust staff and Lancaster University staff. The next sampling days are 28th March and 25th April.

e) Improving Footpath Signage

The Clerk reported that Councillor Brodie has advised that the Lake District National Park Authority have put up a green bridleway sign on the section of the community path leading to the Playground. The National Trust will be putting up a larger sign on the gate at the same location and at the gate at the other end of the path. Councillor Brodie will meet with the Amy McGowan of the National Trust on 19th March to consider the location for a sign near the defibrillator before the National Trust order this.

f) Harrowslack Lake Shore

Councillor Keighley reported that three drop in events have been held by the National Trust (NT), she attended the first one & Councillor Braithwaite attended the one in Far Sawrey. The NT were asking attendees for their suggestions of solutions rather than putting forward any specific proposals. She reported that there continue to be large groups camping at Harrowslack, particularly at weekends but the National Trust security patrols will not take place until the end of March, so the only option available is the phone the Police. Councillor Staton stated that there is a difficulty in removing trespassers unless they are committing a specific offence.

g) CALC training courses

The Clerk reported that she has emailed the neighbouring Parish Councils regarding sharing the Planning Training and Coniston have expressed an interest. As the meeting calendars vary it is likely she will have responses from the others before the next meeting.

h) Registering Parish Council Land

The Clerk reported that she met with Councillor Brodie in relation to registered the Parish Council land and now has an additional 2 boxes of documents in her possession. She is progressing well with collating the information in relation to Chapel Cottage land and next will do the same for the Ash Landing land and the land at Tarn Hill.

i) 20 mph speed limit on Wray road

Councillor Whitworth reported that he has only spoken to 1 resident who supports a 20 mph speed limit at Wray. Councillor Denyer reported that some Colthouse residents are concerned with the high speeds of some vehicles. Westmorland and Furness Council are not yet accepting applications for locations where the national speed limits apply.

Resolved To reconsider once Westmorland and Furness Council are accepting 20 mph speed limit applications for locations where national speed limits apply.

j) Council Emergency Plan

Councillor Hilton reported that he supports the use of Parkhouse as a potential Emergency centre as it includes accommodation and non-electric facilities. Councillor Pender has also supported this suggestion.

Resolved Councillors Hilton and Stanton to meet to consider proposals for the Emergency Plan.

k) Signage and drainage on land in front of Firbank Old School, Far Sawrey Councillor Hilton reported that the sign has been removed, the post remains but the owner is arranging for it to be removed by a contractor. He also advised that the installation of the pipe under the track onto the road has resulted in damp being reduced in the neighbouring house, so is a 'least worse' solution.

 ii) 7/2023/5255. Pearsall House, The Ferry Landing, Far Sawrey, LA22 0LP. Conversion and change of use to hotel with associated landscaping. Revised Drainage Strategy document.

Resolved To object to the Revised Drainage Strategy relating to the foul water proposals for the following reasons:

- There is a statement on page 9 that extra storage for sewage has been made available
 by works undertaken by United Utilities in January 2024, however there is no indication
 as to the volume of extra storage this has created and whether this would be sufficient
 for the new development.
- The calculation on page 17 of Previous Foul Flows for Office of 70 staff relates to staff working in both Pearsall House and Ferry House in 1982. Ferry House has since been converted to 13 apartments (Planning Permission 7/2004/5432) and no calculations have been made to indicate what the increased resulting flows were. Taking an average of 35 members of staff in each office block, this would indicate that Pearsall House staff would have been responsible for around 3,150 litres of foul water and that the Proposed Foul Flows for the Hotel (8,900 litres) would result in an additional 5,750 litres of foul water. There is no explanation of how such a large increase would be accommodated.
- The foul water storage currently has to be emptied by tanker several times a week and
 this will increase substantially with increased foul water flows requiring more frequent
 tankers. There is no indication of how this would be managed during poor weather
 conditions when the roads are impassible, potentially resulting in large sewage
 overflows into Lake Windermere.

 - iii) 7/2023/5614 Rose Cottage, Near Sawrey, Ambleside, LA22 0LF.Construction of outhouse to form WC and utility room to rear garden of dwelling. Approved with conditions relating to plans.
 - iv) 7/2023/5615 High Wray Bank, High Wray, Ambleside, LA22 0JD. Erection of part replacement stone faced boundary wall; and metal estate railing. Approved with conditions relating to plans.
 - v) 7/2023/5779 The Bield, Cunsey, Ambleside, LA22 0LT. Demolition of the existing boathouse, construction of a replacement boathouse and jetty, localised dredging and associated site works. Refused.
